At meeting today, Kyudenko Corporation's Board of Directors resolved to change its name to KRAFTIA CORPORATION on the condition that a related partial amendment to the Articles of Incorporation is approved at the Annual General Meeting of Shareholders scheduled for late June 2025.

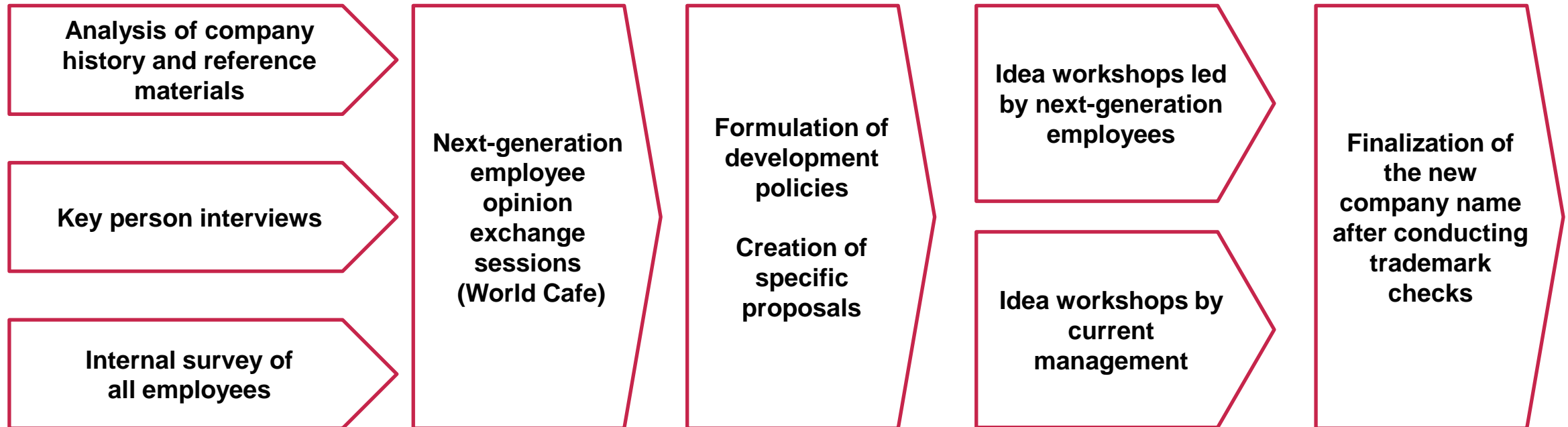
